[As Disasters Strike, Advocates Worry FEMA Policy Changes Put Disability Community at Risk](#)

With Hurricane Florence and Hurricane Michael being the latest in natural disasters, concerns about FEMA policy changes have disability advocates worried. FEMA's Office of Disability Integration and Coordination used to send between 60-65 Disability Integration Advisors to regions during federally declared natural disasters to assist people with disabilities. They have since reduced that number to about 5.

CMS has developed a Disability Index in order to assess current gaps in healthcare access and care for people with disabilities. The index includes disability type and severity. The index has found care disparities for people with disabilities, particularly those who self-rated as severely impaired.
