#### [Voting machines help vision-impaired voters in Alachua County cast ballots](#)

"The number of vote-by-mail ballots in Alachua County is expected to break local records this November, but some constituents may find it hard to independently fill in their ballot because of vision impairment. To help voters with diminished sight cast their ballots, equipment to improve ballot visibility will be placed at polling places throughout the county through the early voting period and on Election Day."

"The data tables present national information on the preschool services funded by IDEA and provided by local school districts and schools. Data are from surveys collected in 2015 from two groups: (1) state agency staff in 50 states and the District of Columbia coordinating grants and services under IDEA Part B Section 619 and (2) preschool special education coordinators in 1,055 school districts selected to represent all districts in the United States."

## [Racism and Disability Discrimination](#)

"Many parents of children with special health care needs — regardless of race — report struggling to receive prompt diagnoses and access to adequate therapy and support services. But for families of color, particularly those who are Black and Latinx, the struggle is more acute."

## [Accessible And Representative Toys Key For Development Of Kids With Disabilities](#)

"Kids with disabilities rarely get an opportunity to see themselves reflected in their toy box heroes and this lack of representative toys also has a knock-on effect on able-bodied children, who are deprived of valuable lessons in normalizing disability through pretend play from a young age. Additionally, many mainstream toys may be inaccessible to children with a variety of impairments such as limitations in dexterity or sight preventing the location and activation of buttons. Fortunately, slowly but surely, representative disability depiction is something that mainstream toy manufacturers are beginning to identify as increasingly important."

## [Improving Representation of People With Disabilities in Health Education](#)

"Over the past two decades, there has been increasing recognition of the importance and merits of increasing representation of historically underrepresented minorities in the health professions. However, people with disabilities are less discussed in these efforts. More than one in four of U.S. adults have a disability; yet it seems that these individuals are less represented in the field of health education. "As we commemorate the International Day of Persons with Disabilities on 3 December, we celebrate an increasing recognition of the leadership and expertise that women and girls with disabilities bring to the table.

Recent calls to apply an intersectional lens to humanitarian action have also led to greater attention to women and girls with disabilities. This is a welcome development, but we must not forget that women and girls with disabilities, and their representative organizations, have been self-organizing and advocating for their rights for decades, both in law and in practice."

## [The Next Wave of Disability Law](#)

"As the Biden-Harris transition moves full speed ahead, and as lawmakers across the country establish legislative agendas for 2021, three key priorities may help advance disability rights. First, the federal government must ensure robust agency enforcement of

care of patients with disabilities.

Applicants must meet the following criteria:

- Recent graduate from an undergraduate program, or currently enrolled in an undergraduate or graduate degree program (Junior or higher class standing) with an overall GPA of 3.0 or higher
- Must be available full time from mid-June to mid-August
- Ability to commit to a 40-hour work week
- United States Citizenship (or hold permanent resident status) or international students currently enrolled in US college/university holding a student non-immigrant visa
- Students with disabilities encouraged to apply"
